#### **New Business:**

City of Portland Contribution- Neil Brown, Director of City of Portland's Park and Rec Department was present to answer questions regarding the use of funds when contribution is made. The city deposits as a Rec Department deposit and uses the funds to offer affordable programs for both youth and adults, maintain the parks, river trail, and splash pad that is being constructed. This contribution will keep the participation costs for residents at the lower rate the city residents pay. Trustee Nurenberg asked Neil to verify if Danby residents were paying more for participation in these activities. There have been several residents that have reported paying an increased rate.

Approval of Contribution to City of Portland Parks and Rec Department in the amount of \$6000 IMSAFE CAC Contribution- Kyle Butler and Lori Kirkhoff were present to answer questions regarding the use of funds when a contribution is made. IMSAFE CAC offers services to both Ionia and Montcalm county residents. It offers beginning to end services for children, under the age 18, who are victims of sexual abuse, trafficking, or severe physical abuse. IMSAFE provides beginning to end services to the victim, siblings, and parents within the walls of one building. This reduces the stress to both the victim and families and supports the police agencies and DHS staff working on case. In 2021, the organization has added a preventative coordinator to the team, this person will provide free services to the schools to build awareness. They have completed 1667 interviews since being established in 2015.
