**RESOLUTION TO ADOPT AN ORDINANCE TO REQUIRE AN ANNUAL PERMIT
FOR MEDICAL MARIHUANA FACILITIES IN DANBY TOWNSHIP**

At a meeting of the Township Board for the Township of Danby, Ionia County, Michigan, held on the 23rd day of March, 2023.

PRESENT: Dan Platte, Erika Hoppes, Kris Platte, Dan Schafer, Bill Nurenberg

The following preamble and resolution were offered by Kris Platte and seconded by Dan Platte.

WHEREAS, the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27101, et seq (“MMFLA”) and the Township Ordinances Act, MCL 41.181 et seq. authorize Danby Township (the “Township”) to adopt reasonable regulations to control the establishment and use of marihuana facilities in the Township; and

WHEREAS, the Township wishes to adopt regulations applicable to medical marihuana facilities in the Township (the “Proposed Ordinance”); and

WHEREAS, the Township Board has determined that adopting the Proposed Ordinance is in the best interest of the Township health, safety and welfare.

NOW, THEREFORE, the Township Board of the Township of Danby resolves as follows:

1. The Township adopts Ordinance No. 2023-2, An Ordinance To Require An Annual Permit For Medical Marihuana Facilities In Danby Township (the "Ordinance," attached as **Exhibit A**).
2. The Ordinance must be filed with the Township Clerk.

3. The Township Clerk must publish either a true copy or a summary of the Ordinance in a newspaper of general circulation in the Township within 30 days after the Township approves the Ordinance. (Exhibit B)

4. Any resolution that conflicts with this Resolution is repealed upon the effective date of the Ordinance.

**NOTICE OF ADOPTION OF ORDINANCE NO. 2023-2, AN ORDINANCE TO
REQUIRE AN ANNUAL PERMIT FOR MEDICAL MARIHUANA FACILITIES IN

**To the residents and property owners of the Township of Danby, Ionia County, Michigan,
and all other interested persons:**

On March 23, 2023, the Township of Danby (the "Township") adopted An Ordinance To Require An Annual Permit For Medical Marihuana Facilities In Danby Township. Section 1. This section provides the title of the Ordinance.

Section 2. This section provides the purpose of the Ordinance.

Section 3. This section provides definitions as used in the Ordinance.

Section 4. This section provides which medical marihuana facilities are permitted in the Township.

Section 5. This section provides general requirements for medical marihuana facilities in the Township.

Section 6. This section provides permitting and inspection requirements for medical marihuana facilities in the Township.

Section 7. This section provides application requirements for medical marihuana facilities in the Township.

Section 8. This section provides the application review process for medical marihuana facilities in the Township.

Section 9. This section provides for renewal and transfers of permits for medical marihuana facilities in the Township.

Section 10. This section provides the fees for permits for medical marihuana facilities in the Township.

Section 11. This section provides for violations and penalties of the Ordinance.

Section 12. This section provides for revocation of permits for medical marihuana facilities in the Township.

Section 13. This section provides that if any portion of the Ordinance is found invalid for any reason, such holding shall not be construed as affecting the validity of the remaining portions of this Ordinance.

Section 14. This section provides that all ordinances or parts of ordinances in conflict herewith be, and the same are hereby repealed, specifically the Danby Township Recreational Marihuana Establishment Permitting Ordinance.

Section 15. This section provides that the Ordinance shall take effect thirty days after publication.
